**PURPOSE:**

The purpose of this bulletin is to issue new Prior Authorization of Pharmaceutical Services Handbook pages for Bronchodilators, Beta Agonists that include instructions on how to request prior authorization for the drugs included in the Fall 2009 PDL update that require prior authorization, including the type of medical information needed to evaluate requests for medical necessity.

**SCOPE:**

This bulletin applies to all licensed pharmacies and prescribers enrolled in the Medical Assistance (MA) Program and providing services in the fee-for-service (FFS) delivery system, including pharmacy services to residents of long term care facilities.

**BACKGROUND:**

The Department of Public Welfare’s (Department) Pharmacy and Therapeutics (P&T) Committee meets semi-annually to review published peer-reviewed clinical literature and make recommendations relating to new drugs in therapeutic classes already included in the PDL, changes in the status of drugs on the PDL from preferred to non-preferred and non-preferred to preferred, and new classes of drugs to be added to or deleted from the PDL.

**DISCUSSION:**

During the August 19, 2009 P&T Committee meeting, the P&T Committee reviewed the Bronchodilators, Beta Agonists class of drugs and recommended that specific drugs within the class be designated as non-preferred, which in turn, required a modification to the guidelines to determine medical necessity for Oral Agents. These recommended changes were subsequently approved by the Department.

**PROCEDURE:**

The procedures for prescribers to request prior authorization of non-preferred drugs, preferred drugs that require prior authorization, and drugs not subject to the PDL that require prior authorization and for pharmacies to dispense an emergency supply of medication when necessary and without prior authorization are located In SECTION I of the Prior Authorization of Pharmaceutical Services Handbook. The Department will take into account the elements specified in the clinical review guidelines (which are included in the provider handbook pages in the SECTION II chapters related to specific therapeutic classes of drugs) in reviewing the prior authorization request to determine medical necessity.

The requirements for prior authorization and clinical review guidelines to determine medical necessity of Bronchodilators, Beta Agonists and updated handbook chapters are included in the attached updated provider handbook pages.

As set forth in 55 Pa. Code § 1101.67(a), the procedures described in the handbook pages must be followed to ensure appropriate and timely processing of prior authorization requests for drugs that require prior authorization.
